**PAYMENT OF FEES:** Payment of fees for services rendered does not guarantee the placement of a child. All fees, timelines and program requirements are subject to change. All fees are billed at the rate that is current at the time of billing. Children's Home may increase fees if adoption expenses in the foreign country increase substantially after time of application. Fee increases in excess of \$1,000 will be made in writing. Program changes may be subject to additional fees. Payment is due in full according to stated timelines. Late payments may result in the delay or cancellation of services. Fees not paid within 90 days of invoice date may incur a 2.5% late fee and referral for collection.

 Cash, money orders or personal checks are always welcome. Please make checks payable to Children's Home.
- Payment by Credit Card or Electronic Bank Transfer**

- Grants or Financial Assistance**  
 Payment is due in full from the AP according to stated timelines. In the event Children's Home receives grant funding or other financial assistance directly on AP's behalf after fees have already been paid, Children's Home will then provide reimbursement to AP within thirty (30) days of receipt of the financial assistance, provided such refunds do not violate the terms of the grant organization and there are no remaining service fees to be paid.

**FEE REDUCTIONS, WAIVERS & REFUNDS:** All fees are non-refundable unless otherwise noted. Children's Home may reduce, waive or refund fees when: 1) deemed by Children's Home to be in the best interest of the child; 2) requested by clients due to hardship; or 3) when paid for services which were not completed. All refunds will be processed within sixty (60) days of the completion of the delivery of services.

## Kidsave Summer/Winter Hosting Program - Colombia



We partner with [Kidsave](#) to help older children from Colombia experience the joys of summer and to help them find permanent, loving, adoptive families through their [Summer/Winter Miracles](#) programs. Colombian children eligible for international adoption stay with host families in designated communities for a 4-5 week visit and learn about the U.S. culture, experience life in an American family, and build lasting relationships with caring adults. Children who participate in the program generally range in age from 11-14. Some may have siblings.

While the children stay here, they learn about the U.S. culture, experience life in an American family, and build lasting relationships with caring adults. As a host family, you'll work with the local Kidsave community to help the children meet potential adoptive families. Some families move forward to adopt the children they host.

This program can be a great option for experienced parents and for those who are not sure if full-time parenting through international adoption is the right fit. We are here to guide families through their required education, support them during the visit, and assist in the adoption process should these children find adoptive families.
