FEE REDUCTIONS, WAIVERS AND REFUNDS

All fees are non-refundable unless otherwise noted. CH may reduce, waive or refund fees when: 1) deemed by CH to be in the best interest of the child; 2) requested by clients due to hardship; or 3) when paid for services which were not completed.
