<b>Court Consent or Termination of Parent Rights (TPR) Fee</b> <i>Flat fee per process for agency to utilize attorney to complete court consent process or termination of parental rights as required by case.</i>	Due at Children's Home initiation of process	\$2,000

**TOTAL COST:** The approximate cost to adopt one child after matching through the agency Family Profile Service is \$21,870 – \$29,945 (not including outside agency, attorney or birth parent expenses associated which can vary greatly). Additionally, the length of time in which your family waits for a match will impact the amount of annual home study updates and annual background checks needed.

**PAYMENT OF FEES:** This is a good faith estimate of the charges deemed reliable as of the date published. The payment of fees for services rendered does not guarantee the placement of a child. Payment is due in full according to the timelines noted above. All fees, timelines and program requirements are subject to change. Agency fees will be honored at the rate that is current when the signed Fee Agreement is received by Children's Home. Late payments may result in a delay or cancellation of services. Fees not paid within 90 days of invoice date may incur a 2.5% late fee and referral for collections.

**PAYMENT METHOD: Check.** Personal checks and money orders are always welcome. Please make checks payable to Children's Home. **Credit Card Payment or Electronic Bank Transfer:** Credit cards or electronic bank transfers may be used to pay for all adoption fees. **CONSEQUENCES OF NONPAYMENT:** Failure to pay fees as scheduled may result in the delay or cancellation of service and/or referral to an agency for collection.

**LEE REDUCTIONS, WAIVERS AND REFUNDS: All fees are non-refundable unless otherwise noted.** Children's Home may refund fees when paid for services which were not completed. All refunds will be processed within sixty (60) days after the request has been approved and the signed agreement has been returned to the agency. Reduction of fees will be considered on a case-by-case basis if requested.

**TAX INFORMATION:** Adoption service fees are not deductible for Federal or State Income Tax purposes, however, qualifying expenses may be eligible for the Adoption Tax Credit (see IRS publication #607, Tax Benefits for Adoption). Please consult with a tax professional to learn more.
