Agency fees will be honored at the rate current when the signed Fee Agreement is received by Children’s Home. Country program fees will be billed at the rate in effect at the time the fee is due. Fee increases in excess of \$1,000 will be made in writing. Program changes may be subject to additional fees. Payment is due in full according to stated timelines. Late payments may result in the delay or cancellation of services. Fees not paid within 90 days of invoice date may incur a 2.5% late fee and referral for collection.

All refunds will be processed within sixty (60) days after the request has been approved and the signed agreement has been returned to the agency.
